While discussing the syllabus for Engineering and Technology Programmes several suggestions are made by Honorable Members.

1. Prof. V. Balamohan Das, Former Vice Chancellor, Acharya Nagarjuna University suggested to change the name of the subject English from Engineering English to English for Engineers if appropriate.
- He also suggested that each and every resolution moved by faculty for approval of syllabi should be accompanied by support from another faculty (I support/I second)
- He also suggested not to address individual experts while submitting the actions taken on previous suggestions.
- He also requested the college to identify any teacher who is really interested in promoting Gandhian thought and nominate him as coordinator for 1500 students of Gayatri Vidya Parishad who can be called as Gandhi Seva Dal and organize events. He highlighted the importance of 2019 as 150<sup>th</sup> Birth Anniversary of Mahatma Gandhi and as a mark of respect he suggested to volunteers to do some social service.

2. Prof. P.S. Avadhani, Professor, Department of Computer Science and Engineering, Andhra University College of Engineering (Autonomous) brought to the notice of members of the Academic Council about SIEMENS CENTRE OF EXCELLENCE that exist in Andhra University College of Engineering which gives training to the students. He said students of GVP can also be benefitted if training is provided as value addition programme.
3. Prof. V. Vallikumari, Professor, Department of Computer Science and Engineering, Andhra University College of Engineering (Autonomous) and Vice Chancellors Nominee, Academic Council suggested to avoid redundancy in the syllabi of Computer Science and Engineering. According to the syllabus there should be advanced topics in the fourth year which is not seen in the present syllabus. She suggested that care should be taken while designing the syllabus next year.
4. Prof. Ch. Ratnam, Professor, Department of Mechanical Engineering, A.U. College of Engineering (Autonomous) and Vice Chancellors Nominee cautioned on grading of students on the basis of ranks they secure in the semester end examinations and suggested to make it compatible with Andhra University grading.
5. The Principal informed the Academic Council that the Science and Engineering programmes wish to start vocational courses in select branches and sought approval. The members of academic council approved the proposal.


He informed and requested the approval of Academic Council to run the M.Sc analytical Chemistry from the Academic Year 2019-2020 onwards.
